CLASSROOM TRAINING

Students attend classes of 2 hours each scheduled day and can qualify to receive a learner's permit after just 3 days. After receiving the instructional permit, students can begin the behind-the-wheel phase of their training while continuing with their classroom theory instruction.

IN-CAR INSTRUCTION

BCD Driving School offers excellent behind-the-wheel instructions which provide practical driving experiences. In-Car instructions are also available for those who have already completed the classroom phase of the Driver's Education Course.

Driving lessons can be scheduled before class, after class or on weekends.

UPON COMPLETION OF CLASSROOM TRAINING AND IN-CLASS INSTRUCTION

Please read thoroughly. Things needed when preparing for the DRIVING TEST for your Class C License at the Texas Department of Public Safety (DPS) or available school administering this test:

Teens 15-16-17

- 1. Texas Driver Education Certificate (DE 964)** Be sure to get this form from the driving school upon completion, please call 512 271 1684 before coming.
- 2. Verification of Enrollment and Attendance (VOE) Form** - You MUST get this from the school that you are attending.
- 3. Texas learner license and Identification Permit** and School or work identity document will be acceptable for proof
- 4. Parent or Legal Guardian** - A parent must accompany you to the Texas DPS. If Legal Guardian, proof must be available

5. **YOU must provide your own State approved vehicle** - This vehicle must pass an inspection (**all documents**) to ensure it is safe and can be legally operated on public roadways. Please arrive one hour early for your appointment for processing and/or payment. If you do not arrive one hour early, your appointment may be rescheduled.
6. **30 Log Hours** - The 30 hours of behind-the-wheel practice must be completed in the presence of an adult who meets the requirements of Section 521.222 (d) 2. (See 30 log hours).
7. The driving test fee (<http://www.txdps.state.tx.us/DriverLicense/dlfees.htm>) Effective April 1, 2015 - Completion of Impact Texas Teen Driving (ITTD) The ITTD Certificate of Completion must be presented and dated within 90 days of the driving skills exam. <https://impacttexasteendrivers.dps.texas.gov>. This driving test is for Class C license (passenger cars) only. 8. **Effective September 1, 2015** - <https://impacttexasteendrivers.dps.texas.gov/> when completion of the Impact Texas Teen Driving (ITTP) Program, Read the certificate carefully before signing it

Graduates are provided certificates acknowledging completion of the State requirements for Driver Education and make the student eligible for licensing. Graduates are also entitled to a 10% discount on their auto insurance policy. Check with your insurance company for more details!
